2015 Volunteer Report for CSERC

2015 was an impressive year for our Center's volunteer restoration projects. We succeeded in engaging more people in more projects on public lands than we ever have before. In 2015, we completed 26 volunteer project days with 219 participants and 1,423 hours of labor donated to get the work done!

As usual the projects that CSERC organized and coordinated were incredibly diverse in resources and locations that were restored by the work accomplished by volunteers. Quantifying the impact that these projects have is difficult because there are benefits above and beyond the actual restoration value. There is the increased pride of stewardship and conservation ethic by participants, or the positive influence they have on their peers in the future, or the visitors whose recreational activity is improved due to the restored environment they experience. These benefits are difficult to measure, yet they are very much a result of the workday efforts.

Other benefits of CSERC's projects are easy to define: thousands of non-native invasive plants were removed from 5 acres of national forest land; 31 acres of meadows were protected or restored; 5 miles of damaging off-road vehicle routes in sensitive habitats were naturalized; ten locations in the forest that are critical habitat for rare animal and plant species benefitted from restoration work; eight watersheds were directly improved by volunteer restoration projects; nine popular recreational locations were cleaned up and restored; and 2.5 miles of wilderness hiking trails were maintained! *To see the details of what was actually done, please look through the attached Project Log Description that describes each project.*

In addition to our highly successful year of performing restoration work, CSERC received the National Award for Stewardship on US Forest Service lands (after being nominated by the Stanislaus National Forest). That award was given to CSERC for work that our staff and volunteers completed in 2014. This was a huge honor that reflected the quality of work that our organization consistently aims to achieve.

We would not be attempting the extensive amount of work we accomplish every year if it wasn't for the support of REI. With REI support, our staff is able to spend the many hours that are necessary to identify and plan projects, to coordinate the events and volunteers, and to follow up with both the land agencies and participants after the work is done.

16. July 25 th	South Fork Stanislaus OHV	6 hr project (78 hours donated)	13	Blocked and naturalized about .75 mile of unauthorized road access to the river; blocked 5 dispersed camping sites to vehicle access along river.
17. August 8 th	Chain Lakes trail maintenance	8.5 hr project (102 hours donated)	12	Brushed and improved drainage (building water bars) on 2.5 miles of hiking trail.
18. August 22 nd	Deer Creek OHV restoration	6 hr project (54 hours donated)	9	Blocked and naturalized over 1.5 mile of unauthorized OHV routes in area with sensitive plants and rare wildlife and riparian restoration needs.
19. Sept. 1 st	Bell Mountain OHV	7 hr project (70 hours donated)	10	Blocked unauthorized hill climb with debris, spread erosion control rice straw, and installed straw wattles/silt fence as needed. Blocked with large debris about .75 mile unauthorized motor vehicle route that borders roadless area
20. Sept. 26 th	Clavey River OHV restoration	6 hr project (60 hours donated)	10	Installed (dug holes and put in ground) 30 8"x8" wooden bollards to stop vehicles from driving in forest along the Clavey River in popular dispersed camping area (watershed protection).
21. Sept. 30 th	Riverside Day Use stewardship	4 project (36 hours donated)	9	Stained 6 picnic tables, 12 benches, 1 10-foot bridge, and one informational sign. Built two waterbars on river access trail to slow erosion. Picked up trash (about 75 lbs) along .5 mile of N. Fork Tuolumne River.
22. Oct.7th	South Fork Road scotch broom weed pull	4.5 hr project (27 hours donated)	6	Removed over 1000 Scotch broom bushes in an area about .5 acre in size.


